# What is CASA?



#### WHAT IS A CASA VOLUNTEER?

CASA (Court Appointed Special Advocate) volunteers are community members who are recruited, trained, & supervised by CASA staff members. All volunteer advocates must pass background checks & are screened for suitability. They are sworn in & appointed by a family court judge, & they advocate for the best interests of their assigned children.

#### HOW IS CASA DIFFERENT THAN CPS?

CASA volunteers are unpaid. They receive training to work alongside others & collect information regarding a child, which includes contacting family members, school teachers, medical providers, & mental health professionals. CASA volunteers provide fact-based court reports & testimony in court hearings. Unlike CPS, CASA volunteers are not legal guardians on cases & are prohibited from providing transportation or supervision services. CASA's **mission** is to advocate for South Mississippi's abused & neglected children by supporting volunteers who promote safety, permanency, & resilience. Our **vision** is a community where all children thrive in safe & nurturing families.

### **HOW DOES CASA HELP?**

Each CASA volunteer maintains 1-2 cases at a time in order to ensure that each child has his or her needs met. CASA volunteers make regular in-person visits, attend family team meetings, assist with educational advocacy, acquire documents & records, and make factbased court recommendations to move a case forward. CASA serves as the eyes and the ears of the court and partners with CPS, community agencies, court attorneys, and more.

# Our Judges



### S. TRENT FAVRE HANCOCK COUNTY COURT JUDGE

The Honorable S. Trent Favre serves as Hancock County's first County Court Judge. Appointed by Governor Phil Bryant in late 2017 & elected twice since that time, his role includes youth court matters involving child abuse and neglect, delinquency matters, & a county court docket. In 2020, Judge Favre was presented with the Mississippi Bar's Judicial Excellence Award. Judge Favre serves on the Judicial Leadership Council of National CASA, and the Mississippi Child Welfare and Access to Justice Commission. Judge Favre is from Hancock County & is a graduate of Bay High. He received a Bachelor of Arts Degree in Philosophy with a minor in French from Millsaps College & he obtained his Juris Doctorate from the University of Mississippi School of Law.

#### MICHAEL DICKINSON HARRISON COUNTY COURT JUDGE

Judge Dickinson is a graduate of Mississippi State University where he earned a Bachelor's of Accountancy and of Mississippi College School of Law where he received his law degree. In 2018, he was elected to serve as a County Court Judge handling all Youth Court matters in Harrison County. He also served in the U.S. Navy on the USS Independence (aircraft carrier) in Japan. Judge Dickinson serves on the Commission on Children's Justice, the Judicial Leadership Council for National CASA and the State Intervention Court Advisory Committee. In 2023, Judge Dickinson was appointed by the Chief Justice of the Mississippi Supreme Court to serve as a member of the Mississippi Task Force on Foster Care and Adoption which was created by the Mississippi Legislature in 2023 SB 2384. Additionally, Judge Dickinson was selected as a 2023 recipient of the Angels in Adoption award by the Congressional Coalition on Adoption Institute for his work in the adoption, foster care, & child welfare community.

# Our Judges



#### SEAN COURTNEY STONE COUNTY REFEREE

Judge Sean A. Courtney was appointed by the Chancery Court of Stone County to serve as Youth Court Referee in 2016. Prior to that, Sean had served as a Guardian Ad Litem in Stone, and many other counties, for approximately ten years. He also serves as the Municipal Judge for the City of Wiggins and represents the Stone County Economic Development Partnership and the Stone County School District. As a referee, he adjudicates cases involving child abuse and neglect, as well as juvenile delinquency. Sean served as a governor on the Mississippi Judicial College Board of Governors from 2013-2020. Judge Courtney is an Air Force Brat who graduated from Biloxi High School before attending Mississippi Gulf Coast Community College and then the University of Southern Mississippi, where he earned a Bachelor of Arts in History, and ultimately received a Juris Doctorate from the University of Mississippi in May 2000. He is a former Rotary Club president, Deacon at First Baptist Church of Wiggins, and currently sits on the Board of Directors for the Mississippi Gulf Coast Community College Foundation and the United Way of South Mississippi.



# Expanded Service Area

In the Fall of 2023, CASA of Harrison & Stone Counties initiated the dissolution of their organization & approached CASA of Hancock County to request help. In response to their request, CASA of Hancock County coordinated with the courts of both counties to expand the program & prevent the loss or lapse of advocacy services for child victims in Harrison & Stone Counties.

# Alek Dickerson

Carol Shiyou was sworn in as a CASA volunteer on February 20, 2014. Carol's Advocate Supervisor Lauren Saucier said, "Our first home visit brought us face to face with an 11-year-old girl who, despite having a rocky road through middle school, was also bright, bubbly, smart, and very outgoing." Carol recalls, "I was told this would be an easy case to get my feet wet. Little did I know that I would be advocating for this young lady **for the next nine years**, & that she would become such an important part of my life."

Alek said, "When God knew I needed a mother, he put Mrs. Carol in my life. She is truly a woman I admire & look up to, & she means so much to me. She has been with me through all my ups and downs & has supported me so much, both mentally and emotionally. I wouldn't ask for anybody else because nobody else is like Mrs. Carol."

Always proud of Alek, Carol says, "Alek had her own drive and always had goals in mind. Her determination & resiliency was apparent in all the work she did. I may have been a voice for her in the court system, but Alek had her own big, brave voice & was not afraid to ask for what she wanted or get what she needed. She was a leader in every role in her life, a talented singer, and set out to be as independent as possible."

In July 2023, Alek was released from CPS custody & now lives with her family & daughter on the Gulf Coast. She earned an associate degree & is deciding her next steps on going back to school, working, & being a full-time mom.

"Alek may be out of custody, but she will always have me in her corner," says Carol.

### **Remi the Courthouse Facility Dog**

Remi is Mississippi's *only* Courthouse Facility Dog. Canine Companions (R) intentionally bred, professionally trained, & certified her as a facility dog after extensive training with her handler Naomi Strawhorn. **Facility dogs** like Remi are screened for their ability to support clients in a high-stress environment. Remi has written permission to work in a variety of professional settings including court proceedings, CPS conferences, inter-agency meetings, & multidisciplinary training events.



### Trust-Based Relational Intervention®

Trust-Based Relational Intervention (R) is an attachment-based, trauma-informed intervention that is designed to meet the complex needs of vulnerable children. Children who have had difficult experiences have often developed difficult behaviors as a result. Over the past four years, CASA has been hosting TBRI trainings that empower caregivers and systems to provide trauma-responsive care. This year, CASA of South Mississippi holds the distinction of being inducted as a TBRI (R) Ambassador Organization, which provides unique access to ongoing support and training for the entire state of Mississippi.
